Continuing an approach started by Itziar Laka, this essay deals with negative statements and shows that four independent criteria make it imperative for Basque grammatians to distinguish between focus, defined exactly as in positive statements, and quasifocus, which is the focus occurring in the denied positive clause.

Abstract: The hydroskeleton plays a central role in the architecture of the trunk and the tail of the chaetognaths; the nervous system remains intraepidermic. A peculiar kind of a synapse appeares several times: they are located in zones where the "basal membrane" is thin (this structure represents the connective tissue of the animals). The nervous system, "the basal membrane" and the locomotory muscle evolved independently; the connective tissue plays an important role in the distribution and in the physiology of myosunapses in this phylum.
