Abstract: The First Additional Clause of the Constitution of the State is fully normative and adds something to the Constitution as a whole: the recognition of different political bodies, the legal expression of which is the Historical Rights. The Historical Territories of the Basque Country, the Basque Country itself and Navarre, have Historical Rights to which the Constitution refers, even though it is possible to extend the application of the First Additional Clause of the Constitution of the State to Catalonia and Galicia. The updating of such Historical Rights, to be carried out in a consensual manner, allows us to introduce the concept of co-sovereignty, that is to say, of conditioning of the competent authorities responsibilities on the very fact of having such a competence. This allows for wilful integration within the Constitutional State.

Abstract: This article corresponds to chapter II of a projected "History of Basque Art". It approaches the topic of the post-paleolithic art up to the Roman era. With the title of "the first abstract art" the author wishes to emphasise the idea that the end of late Paleolithic period also marks the end of realistic art in the Basque region. After some paragraphs dedicated to the cultural context, the author exposes the forms adopted by this "flight from realism" that have been called stylisation, schematism, and abstraction. Subsequently, the author deals with the habitat up to the Iron Age, and megalitism (sense and chronology of the dolmens in the Basque Country) and the appearance of a sense of aesthetics in ceramics. He then covers the recently discovered parietal paintings, their meaning and their comparison with other contemporary paintings in the eastern region of the Iberian Peninsula. The author then shows how artistic creativity arises in objects of adornment and in a rudimentary "sculpture" (the "spatula- idols") and finally, the author deals with the topic of cromlechs and menhirs.

Abstract: This article attempts to note and interrelate what is the real fitting under the expression "Vasconia" of the history of an assorted territorial area between the 7th and 13th centuries. Both because of its extension, and because it is the only territory that attained the superior political rank of kingdom, special attention is dedicated to Navarre. The bases that brought about the birth of the kingdom of Pamplona are analysed in order to be able to follow the sinuous path of the Navarran monarchy up to Teobald I. Although coincident in certain times, Alava, Gipuzkoa and Biskaia followed different political paths. Finally, the evolution of the French-Basque territories is also studied.

Abstract: This article analyses the cultural sediment of early medieval Vasconia. The Muslim irruption in the second decade of the 8th century was to lead two centuries later to a reconquest that would culminate with the recovery of former Vaconia dominions and new lands, with the consequent expansion of the Vascones' culture in what is currently La Rioja and the north eastern end of Burgos. The 10th century saw the birth of the romance languages. The cultural mosaic of Vasconia was enriched as of the end of the 11th century with the people and languages from Franconia and Gascoigne, an element that was already known in Bayona. That multiethnic and multicultural society was completed with a significant Jewish element.
