In the first part of this motion, the author introduces some aspects of this experience, such as its general proposals, objectives, organisation, elaboration of materials, training approach and teacher follow-up, and student evaluation. In the second part, starting from our experience and taking into account the positive aspects and difficulties that are encountered, the author describes those requisites that, from an organisational perspective and that of project management, seem to be important to accomplish an experiment like ours. Moreover, these acquisitional steps are chronologically parallel in the two languages. 


