En la Capitanía General de Burgos se sigue un sumario num. 31 con aplicación del Código de Justicia Militar en juicio sumarísimo contra 15 vascos acusados de delito continuado de terrorismo.

El fiscal pide seis penas de muerte y diversas penas de detención para los quince procesados, que entre los quince suman más de 750 años de duración. Entre los procesados hay dos sacerdotes y tres mujeres.

Las penas de muerte se piden para los procesados Onaindia, Larena, Gorostidi, Uriarte, Dorronsoro e Izco..

Los abogados defensores son Infante y Echevarrieta de Bilbao y Cortezo de Madrid..

El juicio se sigue aplicando el Código de Justicia Militar con arreglo a lo dispuesto en la Ley de Bandejaje y Terrorismo.
